# 3. Item 2: Review of General Band Meeting Minutes from April 30, 2025.

#### 4. Item 3: Presentation: AI Data Centre – Lot 95 & 96 IR 1 (Lot 87)

Guests Quinn Ellerbeck, Rob Malcolmson and Dan Rink provided membership with an overview of the proposed AI Data Centre on Lots 95 & 96 on IA 1 Nicola Lake.

The presentation included comprehensive information that included environmental risk reduction, milestones, and the next steps in the project as well as the potential benefits to Upper Nicola. The proposed project is for 300 MVA, the largest within Canada.

The size of the data Centre will depend on how much power BC Hydro can provide for the project, which has not yet been determined. The life expectancy of the centre is about 20+ years as upgrades as newer technology can be installed as they are made available and fulfill provincial and federal mandates.

The potential environmental concerns for this project have been studied and there is little risk to the environment as the project uses little water, does not put out any radiation into the environment and will use clean energy. The one major output from the project will be heat from the computers which could be used for other uses.

Canada is closing in on data sovereignty and the need to ensure data produced within Canada remains within Canada. Currently, most data centres are in the US and are therefore subject to US laws, including the right to review material at any time. As well, AI produced in the US are also taking on US culture, values, and knowledge. With AI Data centres within Canada will create a more balanced AI product.

Prior to operations, Bell Canada will pay market values rent to UNB and once in operation, UNB will receive 5% off the top from revenues generated, so there will be no cost to UNB.

During the month of June, there will be community engagement sessions for membership and there will need to be a community vote to approve the project to be on UNB lands.
